ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution M.D. B.Ed. College, Pallu, Jat Dharamsal, Main Highway Road, Rawatsar, Hanumangarh, Rajasthan has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- 3. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to M.D. B.Ed. College, Pallu, Jat Dharamsal, Main Highway Road, Rawatsar, Hanumangarh, Rajasthan for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, before 31.10.2015
- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

 - Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph. (b)

(d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance lest, if any, date of admission, etc.

The Vice-Chancellor has been Pleased to grant provisional affiliation to your college to start B.Ed. Course for the session 2008-09 subject to fulfillment of the conditions mentioned below:

- It is mandatory for the college to abide with all the conditions of NCTE letter No. F-1 NRC/NCTE/RJ-1872/2008/59770 Date 02-09-08 and Edu. (Gr.-I) Department, Govt. of Rajasthan Letter No.- F10(6) Edu-I /2007 Date 09-09-08
- If it is found at the time of inspection that college does not fulfill the required conditions of State Govt. and 2 NCTE necessary action will be taken by the University.
- As per the order No. F- NRC/NCTE/ RJ-1872/2008/59770 Date 02-09-08 issued by NCTE the annual intake to the B.Ed. course will be 100 seats. The joint director (Training) Secondary Education Rajasthan 3 Bikaner in its letter No. शिविरा-माध्य/शिप्र/सी/19524/2008-09/16 दिनांक 11.09.08 further classified the seats as follows:

50 seats For Arts faculty 30 seats For Science faculty 20 seats For Commerce faculty 100 seats Total

- The admissions will strictly be made on the basis of merit list of eligible candidates provided by the University which conducted PTET examination.
- To follow and observe the University Act, Statues, Ordinances, Regulations, Rules and instructions framed, amended, adopted and issued from time to time in general and specifically relating to follow curricula/course 5 of study as prescribed by the University from time to time including scheme of examination and conduct of examinations.
- Staff: Appointment of permanent qualified Principal and Teaching staff on the 6 (i) full time basis selected by a duly constituted committee.
 - Building: Construction of sufficient building as per guidelines of the State Govt. & University (ii) provisions, playgrounds and Hostel building.
 - Library: Year-wise development of College library and provision of funds for journals and (iii) magazines be made.
 - Endowment Fund: Sufficient Endowment fund as prescribed in rules may be created.
 - Faculty Members: Requisite qualified faculty members be appointed. (iv)
 - Laboratory: More equipments, chemicals, glassware, dummies, cutting machines display board (v) (vi) etc. may be procured.
 - Appointment of qualified Librarian, P.T.I. and other staff be made as per University and (vii) Government rules.
